PERROTT.

Sir Herbert Charles Perrott, 1st Bart., C.B., late lieut.-col. commanding, and hon. col. 3rd batt. "The Buffs" (East Kent regt.), formerly ensign 21st and 26th Kent rifle volunteers, and captain reserve of officers. Sir Herbert is Knight of Justice from 1876, and secretary-general of the Order of the Hospital of St. John of Jerusalem in England from 1910. He was asst. sec. 1875-88, and secretary 1894-1910.

He has been chief secretary St. John Ambulance Association from its formation in 1877. Sir Herbert b. 26 Oct. 1849; m. 10 Dec. 1901, Ethel Lucy (Lady of Justice of the Order of St. John of Jerusalem and Superintendent-in-Chief Nursing Corps, has Coronation medal 1911), eldest dau. of the late Capt. Marcus Stanley Haro, R.N., of Court Grange, Newton Abbot, by Matilda Jane, his wife, dau. of William and Lady Anna Maria Tollemache, and has issue, Marie Louise Priscilla (for whom H.H. Princess Marie Louise of Schleswig-Holstein was sponsor), b. 20 Dec. 1909. Sir Herbert Charles Perrott was created C.B. (civil) 1902, and a baronet 21 June, 1911, with remainder to the heirs male of his body with precedence from 1 July, 1716.

Lineage—SIR ROBERT PERROTT, styled 1st Bart., of Richmond, Surrey, a scion of the ancient Perrott family to which belonged the celebrated Sir John Perrott, lord deputy of Ireland, temp. Queen ELIZABETH, was, in reward for eminent diplomatic services, created a baronet it is said 1 July, 1716, with limitation to his brother and the heirs male of his body, but no patent was registered in the College of Arms. Sir Robert d. 29 May, 1759. His nephew,

SIR RICHARD PERROTT, styled 2nd Bart., who was eldest son of Richard Perrott, of Broseley, Salop, by Rebecca, dau. of Isaac Wyke, of Wacton Court, Herefordshire. He was present at the battle of Culloden, in personal attendance on the Duke of Cumberland; he subsequently entered the service of Frederick the Great of Prussia, and serving in the Seven Years' War, obtained the order of the Red Eagle. Sir Richard was employed in several confidential negotiations, for which he received the order of the Black Eagle. A royal warrant, dated 3 Jan. 1767, under the sign manual and privy seal (but not under the great seal), countersigned by the secretary of state, the Hon. H. S. Conway (which warrant is entered in the Earl Marshal's Book, College of Arms, I. 32, fol. 53), declared "to avoid all doubt and dispute about the rank and precedence of our trusty and well beloved Sir Richard Perrott, Baronet,—that he the said Sir Richard Perrott, and the heirs male of his body, lawfully begotten, should have and enjoy, in all places, assemblies, and meetings, the place, rank and pre-eminence, precedence, privileges, and immunities, of or belonging to a baronet of this our realm, and to take precedence from 1 July, 1716." SIR EDWARD GEORGE LAMBERT PERROTT, styled 4th Bart., K.J.J., capt. East Kent militia, Vico-President and for over thirty years Chairman of Preparatory Committees of the Royal National Lifeboat Institution and was awarded its gold medal. He was b. 10 May, 1811; m. 13 Oct. 1847, Emma Maria, only dau. of Charles Evelyn Houghton, commander R.N., descended in the female line, from John Evelyn, the accomplished author of *Sylva*, and grand-niece of Sir Hugh Evelyn, last Bart. of Wotton, and by her (who d. 15 June, 1878) had issue,

the island in the Lake of Menteith, which was made a priory in 1238, and was subsequently the burial-place of the Drummonds. Malcolm Beg Drummond was Senechal of Lennox, and m. the dau. of Malcolm, Earl of Lennox, and sister of Malcolm, Earl of Lennox, who resigned his earldom to the king.

SIR MALCOLM DRUMMOND, who obtained additional lands from the Earls of Menteith, had, besides John, his successor, and Maurice, ancestor of the Drummonds of Coucraig and Megginch, a dau.,

MARGARET DRUMMOND, m. 1st, Sir John Logie, and m. 2ndly, King DAVID II. in the chapel of the Priory of Inchmohomo in April, 1363. Against a sentence of divorce from DAVID, pronounced in 1370, Margaret appealed to the Pope, and so great, it is said, was her interest at Avignon, that Scotland was saved from an interdict only by her opportune decease.

JOHN DRUMMOND, eldest son of Sir Malcolm, was Baillie of Dull, and had, in Feb. 1367, a charter of the lands of Mary of Montifer, his wife. Besides three sons, Malcolm, John, and William (ancestor of the Drummonds of Carnock), he had a dau. Annabella, who, in 1397, m. John Stewart, Earl of Carrick, afterwards King ROBERT III., and became, like her aunt Margaret, Queen of Scotland. Queen Annabella, who d. 1401, is ancestress of all succeeding sovereigns of Scotland, Great Britain, and the United Kingdom.

SIR MALCOLM DRUMMOND, eldest son of John, acquired Cargill, Stobhall, Kinloch, and other lands, from his aunt, Queen Margaret. He m. Isabel Douglas, Countess of Mar, and in 1403 was murdered by a band of highland marauders, said to be headed by Alexander Stewart, soon afterwards the Countess's second husband. Dying s.p. he was s. by his brother,

SIR JOHN DRUMMOND, of Cargill and Stobhall, justiciary of Scotland, whose son and successor,

SIR WALTER DRUMMOND, m. Margaret, dau. of Sir William Ruthven, of Ruthven, and had three sons, 1. MALCOLM, his heir; 2. John, Dean of Dunblane; 3. Walter, of Lederieff.

SIR MALCOLM DRUMMOND, of Cargill and Stobhall, d. 1470, having m. 1445, Mariot, dau. of Sir David Murray, of Tullibardine, and had 1. JOHN, his successor; 2. Walter, of Deanston, Dean of Dunblane; 3. James, of Coldick and Ballochard, who had issue; 4. Thomas, of Dromondnoch, who had issue; 5. William, of Muthill; 6. Andrew, of Smitheston. The eldest son,

JOHN DRUMMOND, 1st Lord Drummond, was justiciary of Scotland, a privy councillor, constable of Stirling Castle, and employed in various embassies. He was created a lord of parliament as *Lord Drummond*, in Jan. 1487-8. In 1515, he was imprisoned in Blackness Castle, and forfeited for striking Lyon King-of-Arms (Sir William Comyn), but reponed and restored in 1518. Lord Drummond d. in 1519, aged 81, having m. Elizabeth, dau. of Alexander, 4th Earl of Crawford, and had issue,

2. William, master of Drummond, executed in 1490, for the burning of eight score of the Murrays, in the church of Monzievaird. The Earl of Perth (William Huntly Drummond), Lord Drummond (of Cargill and Stobhall), Lord Maderty, and Viscount Strathallan and Lord Drummond of Cromlix, all in the Peerage of Scotland; hereditary Thane of Lennox, and hereditary Steward of Menteith and Strathearn; late capt. 3rd batt. Black Watch, b. 5 Aug. 1871; s. his father as 11th Viscount Strathallan 1893, and his kinsman, the Earl of Perth and Melfort, as 15th Earl of Perth 1902.

Lineage—The Drummonds, according to unvarying tradition, are of Hungarian origin, Maurice, the first of the family, who settled in Scotland, having come from that country with Edgar Atheling and Margaret his sister, afterwards wife of MALCOLM III.

MALCOLM BEG DRUMMOND, made in the year 1220 a gift of the barony of Uardross to the parsonage of Inchmohomo, in P. & B.
